## **Class XXIV news**

## January's session day: Local and State Government

Whirlwind.

That's the word that comes to mind to describe the two and a half days of the LTC Class XXIV (Best Class Ever!) State and Local Government session days. Day one was held in Kennewick, and provided insight to the class from city officials and county commissioners, not just on



the different local governing bodies, but also on how each of them became involved, and what Class XXIV can do to get involved. Information was provided on how the budgets work in local government, collaboration with local first responders, and the basics of how the government functions. After a full day of information and involvement, the class boarded the bus bound for Olympia.

Day two for the class began with a walking tour of the capital, including history, fun facts about the buildings, and explanations of the different chambers and how they function. The tour guide was extremely knowledgeable and engaging. Accompanying Class XXIV were members of the Tri-City Legislative Council (TCLC). The TCLC presented to the

class their position papers, escorted the class to committee hearings, and brought in lobbyists, senators and state bureaucrats to help answer questions and inform them of upcoming issues. The class met with the Deputy Secretary of State to learn how the office is run and become informed about the election process, and local Congressional members Senator Sharon Brown and Representative Boenke talked about their upcoming key issues. Craig Maloney (Class VIII) was gracious enough to allow class members to shadow him in his dealings with senators and representatives as he discussed with them his issues as a councilman for the City of Pasco. Closing out the day was Lt. Governor Cyrus Habib, who shared his views, the challenges he has faced, and information about the roles and responsibilities of the Lt. Governor. The day was kept in constant motion with fascinating speakers and plenty of sights to see.

Packed with a lot of information, and many steps logged on their FitBits, the class reconvened at the hotel to a reception hosted by the TCLC. This author is not allowed to divulge many details of the evening reception, except to say that the buffet was tasty and there were some karaoke moves that may never again be performed in public.

Class XXIV would like to express its sincere appreciation to the planning and effort that went into coordinating such an amazing learning experience! This could not have been an easy event to organize, and we are grateful for the hard work that was put in to providing us with this opportunity.
