October's session day: Human Needs and Services

Leadership Tri-Cities Class XXIV - Human Needs and Services Session

The focus of October's session was on the services and programs available to meet human needs in the community.

The day session began with a **tour of the new Boys and Girls Club** in Kennewick. Brian Ace, Executive Director, Class XIII, gave a brief history of the club in the community, sharing the story behind the new facility and the selection of the site. The class enjoyed hearing Brian's story and touring the new 30,000 square foot facility, now under construction.

Class XXIV's day was only beginning – they first travelled to the United Way for a **Life Simulation** sponsored by Gesa Credit Union. The Life Simulation experience helped class members to get an understanding of what it might be like to live in a typical low-income family trying to survive from month to month; often only one major life event away from poverty. The experience was quite enlightening and humbling for many. The rest of the day the class heard from six panels consisting of over 20 leaders from across the community who demonstrated their personal commitment to supporting people in need. Each leader shared at least one compelling story about the members (patients) they serve.

Reflecting on the day, the class was impressed by the personal and professional commitment of the community leaders working in the support of advancing Human Needs and Services in the community. Many of these leaders dedicate their lives to service – one in particular over 35 years.

Throughout the day Leadership Tri-Cities Class XXIV was exposed to many leaders who "Set the example by aligning their actions with shared values".

What you will be looking for will change depending on which event you are judging.
