Class XXV Graduation



Wednesday, September 9, Class XXV will finally be able to graduate Leadership Tri-Cities. The class faced several challenges this year, which not only tested their perseverance and drive, but also challenged the Leadership Tri-Cities board and session directors to develop new ways to provide quality content for the class while observing social distancing guidelines during COVID-19.

From Zoom class sessions to a virtual fundraiser and modified project tasks, Class XXV rolled with the punches. Regardless of the challenge, they persevered! Class XXV's project was to support ANSIL "A New Start in Life" by renovating critical classroom and common spaces in their facility. ANSIL provides shelter, services, support, training, and advocacy to individuals who are seeking to change the circumstances of their lives by learning the skills and training necessary to gain independence while being provided transitional housing. The age group of ANSIL's clients is late teen - therefore the initial fundraiser was going to be an in-person event focusing on the rite of passage of high school. Unfortunately, this was scheduled during the time most of us were getting our stay-at-home orders. The class re-grouped and adjusted their fundraising event to fully online, and still raised over \$18,000 to renovate and support ANSIL and their facility.

Even the project itself needed adjusting. Even with the small class size, there was no way that all class members would be able to meet at one time. Smaller working groups, a later start, and the general requirement that even all class meetings had to be held via social distancing provided the class with an experience unlike any other in the history of Leadership Tri-Cities. Please reach out to any of the class members you may know and congratulate and encourage them for a job well done!

Because we are still in only a modified Phase I in Benton County, the graduation event will also be a small, "drive-in" event this Wednesday, September 9.
